  2. That I am a Legal Officer of the Ghana Revenue Authority.
  3. That I have the consent and authority of Respondent to depose to the facts contained in this Affidavit which, unless otherwise stated are facts which have come to my attention and knowledge as the Legal Officer of the Ghana Revenue Authority.
  4. That Respondent has been served with Applicant's Motion on Notice for Leave to Amend Reliefs and Grounds of Application and is vehemently opposed to substantial parts of same.
